# Kural Pm **KEC Board names Lee Tafanelli as new CEO**

#### Major General LEE TAFANELLI has accepted the position as Chief Executive Officer of Kansas Electric Cooperatives, Inc. effective

on or about May 1, 2020. Tafanelli currently serves as the Kansas Adjutant General, responsible for three primary duties: ensuring the wartime readiness

of over 7,000 soldiers and airmen of the Kansas Army and Air National Guard, coordinating the overall emergency preparedness for the state's response to natural disasters and emergencies, and serving as the Homeland Security Advisor for the state of Kansas.

Tafanelli served in the Kansas House of Representatives from 2001-2005, when he took a leave from office to command the 891st Engineer Battalion in Iraq. After his deployment, he resumed his legislative post in 2006 where he served until January 2011, when he was appointed Kansas Adjutant General.

During his time in the Kansas Legislature and as Adjutant General, Tafanelli developed a deep interest and focus on issues affecting

rural Kansas. "I'm honored and excited to have the opportunity to lead a group that does such important work for Kansans in rural areas," he said. "I have deep respect for the complex challenges faced by KEC members who work hard everyday to provide critical and reliable service for Kansas communities."

"Major General Tafanelli has dedicated himself to public service and defending our nation," GOVERNOR LAURA KELLY said. "In addition to his work with the Kansas National Guard. the Adjutant General led the Kansas Department of Emergency Management, where he has been responsible for marshalling resources to communities that have been impacted by disasters such as tornadoes, flooding and more recently wildfires. His efforts and leadership have benefited Kansans statewide, and I have no doubt that he will continue this same level of commitment and dedication in his new role outside of government."

Tafanelli will replace Bruce Graham who has announced his plans to retire as CEO of KEC. Graham has 40 years of association and electric cooperative industry experience and has served as KEC CEO since 2012. He will continue to lead KEC until the transition date.

## Charles Ayers to be inducted into the Kansas Cooperative Council Hall of Fame

**CHARLES AYERS**, a retired board member from Wheatland, will be inducted into the Kansas Cooperative Hall of Fame.

The Hall of Fame, sponsored by the Kansas Coop-

erative Council, is valued for recognizing the contributions of co-op pioneers and honoring those who have gone "above and beyond the call" in advancing the cooperative philosophy.

Ayers has given decades of service to electric cooperatives. He served on the Wheatland Board from 1986 to 2017. During that time, he also served on the boards for Sunflower, Western Fuels Association, ACES Power Marketing, and the National Rural Utilities Cooperative Finance Corporation (CFC).

He was nominated for his advocacy, innovation, and vision that has had lasting effects on the electric cooperatives in Kansas.

"Charles lobbied hard for the Sunflower Holcomb 2 Plant, played a major role in the restructuring of the Sunflower RUS debt, and helped champion the change to the Retail Service Act that provided for the equitable protection for electric cooperatives when municipals seek to annex electric cooperative certified service territory," said **WES CAMPBELL**, Sunflower Board Chair.

"Charles was instrumental in the purchase by Sunflower and its members of the Aquila electric system in 2006," Campbell continued. "All of these accomplishments have helped to ensure the long-term viability of Sunflower and its members."

"As we worked together with legislators and regulators, he never lost his focus on the individual farmer, rancher, or business person that we were seeking to serve," said **EARL WATKINS**, retired Sunflower President and CEO, who nominated Ayers for the Hall of Fame award.

Ayers will be inducted into the Hall of Fame on March 11 in Wichita.

Also to be inducted is **STEVE RIEGEL**, who served as Board Chairman of Ford Kingsdown Co-op and who currently serves on the Board of Directors of CHS, a leading global agribusiness company owned by farmers, ranchers, and co-ops across the United States.

After a reception and dinner, Ayers and Riegel will be honored for their commitment to the growth and development of the cooperative movement.

The two inductees' biographical information will be placed alongside other honorees in the Kansas Cooperative Hall of Fame showcase display at the Kansas State Fairgrounds. Located in the Pride of Kansas Building, this permanent display highlights the achievements of Kansas' great co-op leaders and preserves co-op history. It also plays a significant role in educating others about the uniqueness of the cooperative business model.

Since it was established in 1999, 47 individuals from all types of cooperatives have been inducted into the Kansas Cooperative Hall of Fame. Nominations for potential inductees are accepted each December.

The 2020 Legislature began Jan. 13. Legislators typically spend the weekdays from Jan. 13 to April 3 in Topeka, and then return home for the weekends where they can be found at legislative coffees or town hall events.

Throughout April during what is known as first adjournment, legislators continue to hold events back home while they wait for final consensus revenue estimate numbers. Those numbers assist in finalizing the state's budget and provide an opportunity to make any necessary adjustments during the veto session in Topeka on April 27.

The veto session typically runs until the legislature hits the 90th day, which is currently slated for May 13, but can end earlier or later. Legislators will anticipate the end the legislative session so they can focus on the 2020 campaign trail. What is KS Energy Facts?

## Sub. SB 69 study of Kansas retail rates released

On Jan. 8, London Economics International LLC (LEI) released its study of retail rates of Kansas electric utilities. The document is available online at http://bit.ly/sb69study.

LEI was retained by the Kansas Legislative Coordinating Council to perform a study of retail rates of Kansas electric utilities as mandated by Substitute for Senate Bill 69 passed by the 2019 legislature.

The stated purpose of the study is to assist future legislative and regulatory efforts in developing an electric policy that includes regionally competitive rates and reliable electric service.

The 324-page report recognized that the current electric cooperative ratemaking process is in the public interest and ensures consumer interests are primary considerations.

A new cooperation project between Enel Foundation and the Fulbright Program has resulted in four internships to U.S. students in the fields of electricity, energy transition, and climate mitigation. The internships will be carried out at Enel Foundation in Rome.

Applications are open for candidates with all degree levels with at least two years of studies in the electricity sector in technical, policy, financial, or legal fields.

The grant period is May through July 2020. Tasks include providing support to senior researchers.

# Sunflower, Mid-Kansas Electric merge

Sunflower Electric Power Corporation announced its merger with Mid-Kansas Electric Company Inc. effective Jan. 1, 2020. The merger of the two cooperatively operated, wholesale electric utilities incorporates Mid-Kansas into Sunflower.

Regulatory filings for the merger were submitted in Aug. 2018 to the Kansas Corporation Commission, which approved the merger in March 2019. Sunflower and Mid-Kansas also filed with the Federal Energy Regulatory Commission to obtain approval to combine transmission zones and rates.

In 2005, Sunflower's six membercooperatives formed Mid-Kansas to bid on the sale of Aquila's Kansas Electric Network properties. Member-owners of Mid-Kansas include five distribution cooperatives and one wholly owned subsidiary of a distribution cooperative that serve in Kansas. Mid-Kansas began operation on April 1, 2007.

The intent of Sunflower's and Mid-Kansas' member-owners has been to merge the two generation and transmission providers to capitalize on synergies and offer added value to their members. Savings will result from operational efficiencies and access to lower financial lending rates due greater financial stability of the merged entities.
