# Pandemic leads KEC Board to adopt virtual meetings

Amid the continued disruptions of the COVID-19 pandemic, Kansas Electric Cooperatives, Inc. has found new ways to conduct business as usual. For the first time in the association's history, a board meeting was held via a conference call, and materials were distributed through the BoardPaq app.

"During this time of social distancing due to the COVID-19 virus, we have had to adapt in many ways, learn new communication tools, and conduct busi-

ness remotely," said KEC Board President **TERRY HOBBS** at the beginning of the meeting. "While we would all prefer to be meeting in person, the conference call still enables us to speak and engage in the agenda."

Many of the typical agenda items for the board meeting were not able to be discussed since so many in-person meetings and activities had been cancelled. However, approximatley 70 board members, managers, and staff were able to hear reports on activities and the new ways KEC has found to help meet its members' needs.

During the call, the KEC board members

welcomed KEC's new CEO, LEE TAFANELLI.

"Describing these times as unprecedented may be an understatement, as all of us work to navigate these uncharted waters of the COVID-19 pandemic," said Tafanelli. "I believe challenges create opportunities. The pandemic has abruptly changed how we do business now and will transform how we conduct business in the short and long terms. This is a time for us to reexamine how we do business, how KEC serves its member co-ops, and how we work together to overcome obstacles and discover new possibilities."

Board President **RONALD GRIFFITH** commented, "Kirk is the latest in a long line of Prairie Land executives who was recognized as an outstanding talent when he was hired. He set himself apart by the way he conducted himself while handling mission critical responsibilities, and he responded to the mentorship of the senior members of the management team in a positive way to become the leader he is today."

Look added, "Not only has Kirk been a key management partner here at Prairie Land, he is a highly respected member of the rural electric cooperative community across the state of Kansas having been involved in meetings at Kansas Electric Cooperatives and Sunflower Electric Power Corporation for several years. In those organizations' board rooms, Kirk will be a strong advocate for rural electric cooperative principles and for the members of Prairie Land Electric Cooperative. The Prairie Land Electric family will be in very capable hands."

This year, two Kansas communicators, **SARAH FARLEE**, FreeState, and **JERRI WHITLEY**, Victory, won national awards.

Farlee currently serves as the public relations and marketing specialist for FreeState. She was originally hired in 2015 by Leavenworth-Jefferson Electric Co-op prior to the consolidation with Kaw Valley Electric in 2017. She earned her Certified Cooperative Communicator credentials in 2018.

She received an award in the Best Special Publication for a small cooper-

## PSE reports on impact of COVID-19 on electric utilities

Economies in the 12 Midwestern states have been severely impacted by businesses stoppage due to the COVID-19 pandemic lockdowns. The pandemic has also affected energy consumption and peak demand.

"The shutdown of businesses has led to over 3.7 million unemployment claims in the region, as of the end of April," stated Power System Engineering (PSE) lead forecaster **HARRY JOHN**, Ph.D. "The pause in economic activities is compounding an already fragile Midwest economy beset by a weak agricultural sector and dwindling oil prices."

PSE estimates Midwestern states' real gross domestic product to decline between 2.8% to 5.5% in the first quarter of 2020 as a result of business closings.

"The deteriorating economic activities and growing job losses resulting from business shutdowns are certain to have an impact on the energy industry," said John. "The magnitude of the impact to electric providers will largely depend on their customer mix. Electric providers that depend largely on industrial and commercial customers for a sizable portion of its revenues will tend to be impacted the most."

Many regions are experiencing reduced energy consumption and peak demand, which may lead to revenue losses for investor-owned, municipal, and cooperative utilities.

The length of businesses shutdown and the extent of the lasting impacts are uncertain. However, the PSE experts have identified several action steps cooperatives can take to combat these issues. These action steps include performing revenue and margin sensitivity related to potential loss of load related to key accounts or industry most affected by COVID-19 and analyzing fixed cost recovery in rate design to smooth out future disruptions.

"While I won Spotlight awards in other categories over the years, I was never successful in the Annual Report category," said Whitley. "Over time, that lack of success became a source of great frustration for me, but yet encouraged and motivated me to create a better annual report document each year by being more strategic and presenting the content in a more creative and engaging manner. I guess you could say it became my Spotlight 'goal category."

Farlee and Whitley are among the 123 winners representing 76 electric cooperatives that will be honored during the Spotlight on Excellence Virtual Recognition Celebration, May 27 at 1 p.m.
