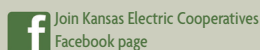

## Heartland hosts first of seven scheduled *Flip the Switch* events

With the flip of a switch, Heartland dedicated two one-megawatt solar farms on May 11. The installations are located outside Girard and Chanute. This event marks the first of seven scheduled *Flip the Switch* events for Kansas electric co-ops.

These solar farms are the first two of 22 to be built as part of the Kansas Cooperative Sun Power Program, a Today's Power, Inc. (TPI) solar power services agreement program that ensures low-cost renewable energy to 12 participating Kansas electric co-ops. Once all 22 solar farms are completed, 80,000 homes will be powered by the 20 megawatts of capacity the farms will produce.

Both of Heartland's newly-dedicated Greenbush and Urbana solar farms were customized in the design process to maximize output during

the cooperative's peak demand hours, when power is most expensive. These factors will all help Heartland control power costs and keep power affordable for its members.

Heartland will purchase electricity generated by the sun farms at a fixed-

low cost for the length of the 25-year-or-more agreement. TPI owns and operates 100% of the solar array.

Six additional *Flip the Switch* events have been scheduled so far, and they are: **FREESTATE** on May 26, **SEDGWICK COUNTY** on May 27, **TWIN VALLEY** on June 10, **4 RIVERS** on June 21, **DSO** on June 22, and **BUTLER** on June 23.

Construction on the other projects will take place in phases running through 2022. Individual projects for participating co-ops will be announced as initiated and completed.

## Co-ops strengthen connections during Legislative Conference

More than thirty cooperative leaders representing 18 electric co-ops serving Kansas consumer-members registered for NRECA's 2021 Virtual Legislative Conference held April 19-21.

The meeting was an on-line alternative to the long-standing April fly-in to Washington, D.C. It included updates on key cooperative issues before Congress and tips for making the most of virtual Hill visits with delegation members.

KEC hosted separate virtual visits with Kansas delegation members Senators **JERRY MORAN** (R-KS) and **ROGER MARSHALL** (R-KS), and Representatives **RON ESTES** (R-KS 4), **TRACEY MANN** (R-KS 1), and **JAKE LATURNER** (R-KS 2). More than 30 co-op leaders joined

in each of the discussions and briefed the delegation on issues including RUS loan re-pricing, increasing postal rates on not-for-profits, and co-op concerns and potential contributions in moving to a lower-carbon future.

"We know our Senators and Representatives are very busy and we are fortunate to have had the opportunity to share with them personally, even if through a remote platform," said **LESLIE KAUFMAN**, vice president of government relations and legal counsel. "We extend our appreciation to them and their staff members that participated or helped coordinate the events."

The 2022 NRECA Legislative Conference is scheduled for May 2-4.

## ElectroRally program offers unique learning environment for students

On May 3, high school teams across Kansas and as far away as Louisiana competed in the Touchstone Energy ElectroRally in Kansas City. This race was the third and final of the state races for Kansas. The other events were held April 14 in Hoisington and April 22 in Scott City, bringing together a total of 16 teams and hundreds of students.

The student teams build vehicles from scratch using lightweight components such as aluminum frames and bicycle wheels. Motors and controls are typically smaller versions of the same technology used in full-size electric vehicles (EVs). While there are specific rules, the teams are allowed much flexibility in the design and composition of their vehicles.

The ElectroRally program involves physics, mathematics, electronics, auto technology and graphic design. As the

teams are creating and racing their vehicles, students have the opportunity to participate in different aspects of the race, including design development, securing sponsorships, writing a paper, or being a driver or pit crew member.

The competition is based on time and distance, and the race is won by the team that completes the most laps in one hour.

Students build vehicles to race in either the Standard Class, that uses only batteries, or the Solar Class, that uses both batteries and solar panels.

This year, the top teams in the Standard Class were Scott City High School and Hays High School. The top teams in the Solar Class were Scott City High School and Dighton High School.

Co-ops are encouraged to be involved by sponsoring local teams or volunteering at race events.
