Co-op linemen deliver safety message at Kansas State Fair

Guided barn tours, laser light shows, and a butterfly house were just a few of the new features that were found at the 2018 Kansas State Fair. But one exhibit that continues to spark interest with fair-goers is the high-voltage line safety demonstration sponsored by Kansas electric cooperatives and Touchstone Energy cooperatives of Kansas.

Celebrating its 11th year, the safety demonstration ran from Sept. 10 through 14 in the Ad Astra Pavilion. Kansas electric cooperative linemen presented the interactive demonstration using real electric equipment and their “volunteer” stick man to show the importance of education and public safety around power lines. The presentation helped viewers learn safety precautions, what protective gear linemen use, and what can happen if a person comes in contact with an energized line.

Midwest Energy provided the demonstration materials, a narrator, and a trainer for each day of the safety presentation, while Flint Hills, Lane-Scott, Pioneer, Victory, and Wheatland volunteered linemen to operate the demonstration.

Kansas State Ag Forum



Electric co-ops to participate in Kansas Energy Efficiency Expo

Three electric cooperatives will participate in the Kansas Energy Efficiency Expo, to be held on the south lawn of the Kansas Statehouse on Oct. 5, 2018.

Bluestem, FreeState, and Lyon-Coffey staff will host a booth targeted toward residential energy efficiency. The co-op booth will feature the Touchstone Energy Efficiency modules, which showcases comparisons of different types of lighting and different types of

insulation, and a water heater display.

The Kansas Governor’s Office will issue a proclamation declaring Oct. 5 as Kansas Energy Efficiency Day, mirroring the National Energy Efficiency Day movement, whose theme for 2018 is “Save Energy, Save Money.”

The expo will be held from 9 a.m. to 3 p.m. There will be demonstrations, displays, drawings, giveaways, and a food truck.


Kansas electric cooperatives raised approximately \$6,175 as 140 golfers competed in the 22nd annual KCRE Golf Open on the greens of Sand Creek Station Golf Course on Aug. 24.

The Tournament Champions were Pioneer’s team of **JACOB MENDOZA**, **DREW PETERS**, **TOLAN SEGER**, and **CHRIS WAGNER**, posting the lowest score of 58 among the 35 teams.

The lowest scorers from each of the event’s five flights were: KEC, Federated, Midwest Energy, Prairie Land, and Bluestem. In addition, 19 hole prizes were awarded.

Next year’s tournament date is Aug. 23, 2019, and will be held at the Sand Creek Station in Newton.

Sen. Roberts staff applauds *Kansas Country Living* article



JOHN HOBBS THINKS of the famous line from the movie "Field of Dreams" when he talks about the evolution of the new reservoir he manages in southwest Kansas. He admits, though, they had to go one step further than building the lake to get folks to come.

"We added water and they came," Hobbs said. "And that's no joke. Our campsites have been full every summer weekend since the lake filled completely."

About 100,000 visited HorseThief Reservoir for day use or overnight last year, the first complete year with a full lake. Hobbs said they're on pace to top that in 2018. The 450-acre lake surrounded by 1,400 wooded acres is about 22 miles north of Dodge City and 40 miles east of Garden City. The nearest town is Juntura, about 10 miles away.

HorseThief, a Victory Electric Cooperative member, pulls visitors from all of those communities and throughout western Kansas—a region thirsty for recreational water.

"What's really unique about us here in the south-west region is that we are a recreational lake, so you can boat recreationally, you can water ski and jet ski in addition to swimming and fishing," Hobbs said.

The reservoir also sees travelers from the panhandles of Texas and Oklahoma as well as eastern Colorado. Hobbs said it's more affordable for Coloradans to head east to HorseThief than venture to the lakes in Colorado that are often crowded with fishing, limit recreational use and full of cold water.

The Hart family from Syracuse, Kansas, near the Kansas-Colorado border, was one of the earliest users of HorseThief and soon preferred it over their usual lake destination, John Martin Reservoir State Park in southeastern Colorado.

"HorseThief has a real family atmosphere with genuinely friendly people running it," said Sheila Hart, whose husband and their five children traveled by RV to enjoy boating, jet skiing and fishing.

Funded by sales tax collected in Ford, Finney, Gray and Hodgeman counties, work on the reservoir began in 2008 and the dam was completed in 2009. It filled halfway that fall and in 2010, HorseThief opened for day-use fishing. In 2012, they opened camping and in 2016 the lake filled completely.

HorseThief Reservoir has 55 water/electric campers, four utility campers that also have sewer hookups and an unlimited amount of primitive sites available.



HorseThief Reservoir is stocked with crappie, large mouth bass, catfish, walleye and bluegill.


