Kansans lead discussions at CFC's annual summit

Key cooperative staff from across the nation attended the 2017 CFC Independent Borrowers Executive Summit (IBES), held Nov. 12 through 15 in San Francisco. This annual conference provided CEOs, CFOs, and leaders of non-RUS borrower cooperatives with a unique opportunity to network, hear from prominent experts and gain insights on the latest industry, finance and management challenges and opportunities.

KEC's CEO Bruce Graham was part of a panel that discussed political activity by the Trump administration related to energy issues, the status of the clean power plan, the U.S. Department of Energy and FERC grid resili-

ency initiatives, regulatory reform, and progress to fill key appointments in federal agencies. Graham also spoke about the importance of initiatives such as Co-ops Vote and the positive impact it has had on communication regarding legislative issues in Kansas. Other panelists included NRECA's Kirk Johnson and Texas-based Golden Spread Electric Cooperative's CEO Mark Schwartz.

Harris also moderated a discussion with Michael Haggarty, Associate Managing Director of Moody's Investors Service, on the current and future state of nuclear power locally and internationally in a session titled "The Future of Nuclear: The Global and U.S. Electric Utility Perspective."

"I am honored to have the opportunity to join the KEC team," Kaufman said. "I have the utmost respect for the association and the



USDA announces State Directors

On Nov. 3, U.S. Secretary of Agriculture Sonny Perdue announced a slate of Farm Service Agency (FSA) and Rural Development (RD) State Directors, all serving as appointees of President Donald J. Trump. FSA State Directors help implement USDA policies in planning, organizing, and administering FSA programs in their respective states. They are also responsible for running the day-to-day activities of the state FSA office. Similarly, RD State Directors work to help improve the economy and quality of life in rural America.

For Kansas, **DAVID SCHEMM** was appointed as the FSA State Director. He has served as President of the Kansas Association of Wheat Growers and President of National Association of Wheat Growers. **LYNNE HINRICHSEN** was appointed as the Rural Development State Director. She joined the Kansas Department of Agriculture in 2013 as the Agribusiness Development Director. Prior to serving in the public sector, Hinrichsen worked in sales, marketing, advertising, and human resource consulting.

"These state directors will help ensure that USDA is offering the best customer service to our farmers, ranchers, foresters, and agricultural producers across the country," Perdue said. "FSA and RD both play a critical role in helping the people of agriculture, and are able to connect with people in their home states. They are the initial points of contact for millions of our USDA customers. Our goal is to help rural America prosper, and these state leaders will be of great assistance in that task."

KEC District Meetings featured strategy, safety, and social media

More than 200 managers, directors and key staff attended the KEC District Meetings held Nov. 1 in Mayetta, Nov. 2 in Hays, Nov. 3 in Dodge City, and Nov. 6 in Parsons. This year’s agenda covered a wide range of topics including strategic planning, the KEC budget review, a Kansas legislative outlook, and a variety of staff presentations.

Bruce Graham kicked off each meeting with the KEC year in review, listing accomplishments across all of the departments and the work done through the four mutual aid events in 2017. Throughout the day, he quizzed the attendees on various KEC services, offering prizes for correct answers.

Graham also reviewed the KEC Strategic Planning process in detail and shared the mission and vision statements, as well as listing the immediate priorities that were identified by the Strategic Planning Committee.

Bob Hall reviewed the KEC proposed budget and discussed the impact of KEC’s Apparatus Testing Department sale.

Shana Read explained why it was important for cooperatives to be engaged with social media.

Alex Orel shared recent Co-ops Vote activities, discussed legislative issues, and distributed a handout listing 10 tips on how to be a good legislative advocate.

Larry Detwiler shared safety tips and best practices at home and on the

farm. With assistance from the attendees, he demonstrated how the linemen are trained to stay safe around blood-borne pathogens. He discussed step potential and showed the effects of electricity on the human body.

Doug Shepherd gave an overview of the local, regional, state and federal groups that KEC staff work with on behalf of the co-ops.

During the meetings, each District elected a representative to the KEC Executive Committee. Western Kansas legislators learn about electric industry, Co-ops Vote

On Oct. 3, KEC joined co-ops in western Kansas to host a Co-ops Vote event for 13 Kansas legislators. CMS, Lane-Scott, Midwest Energy, Pioneer, Prairie Land, Sunflower, Victory, Western, and Wheatland cooperatives participated in the event.

The legislators and co-op representatives toured the Sunflower facility in Garden City, as well as Holcomb Station. Participants also watched a safety demonstration. Stuart Lowry, Sunflower CEO and President, gave an update on the cooperative's projects and challenges.

"The electric industry is ever changing, and the changing nature of our business brings with it both opportunities and challenges," Lowry said. "Rural electric cooperatives have unique matters to address due to location and population density. It's important that we are proactive in addressing those matters so that we can continue to provide reliable energy to our members and those they serve."

Lowry reviewed the status of several projects and discussed the struggles associated with having more wind energy

in the system than demand for electricity. He also noted that Sunflower and Mid-Kansas will continue to advocate on behalf of co-op members so that local ratepayers are not unduly burdened by the cost of transmission to move wind energy to other regions of the country.

After the tours, KEC coordinated the Co-ops Vote event, one of six such events involving 20 Kansas electric cooperatives. Although 2017 is not an election year, KEC continues to build on the success of last year's Co-ops Vote events to give co-op

staff opportunities to build relationships with legislators. During the Co-ops Vote event, legislators shared the issues they expect to be discussed during the 2018 legislative session.

"These events provide a chance to give legislators more information about our issues. It's all about getting our legislators to visit our member cooperatives. Legislators are sometimes still surprised to learn that we are not-for-profit utilities and that electric cooperatives are a unique business model," said Alex Orel, KEC's Manager of Government Relations.
